RECIPROCAL AGREEMENT

This Reciprocal Agreement, by and between OPORTO CRICKET & LAWN TENNIS CLUB and El Real Club de Tenis de Oviedo, is to provide reciprocal facilities between the two Clubs.

A) PARTIES & DEFINITIONS : Certain terms used in this Reciprocal Agreement shall have the meaning set forth below for each such term.

| “Reciprocal Club” | Either or both of the two Clubs entering into the Agreement |
| “Host Club” | The Club visited by the member of the Reciprocal Club |
| “Visiting Member” | The member of the Club visiting the Reciprocal Club |
| “Member” | A bona fide member of the Reciprocal Club within the Rules and Bye-Laws and Regulations of that Reciprocal Club |

B) RULES AND REGULATIONS: It is the wish of the Committees of the OPORTO CRICKET AND LAWN TENNIS CLUB and the El Real Club de Tenis de Oviedo that the facilities of each Reciprocal Club should be available to all categories of membership of the Reciprocal Club subject to the conditions as set out below:

- 1) Members of either Club may be permitted to benefit from the facilities and privileges of the Reciprocal Club provided they are in good standing with their Club.
- 2) Visiting Members will be required to provide a valid Membership Card and Letter or Card of Introduction authorised by the Secretary or the appropriate officer at their own Club when requesting facilities as in paragraph 1) above, before facilities can be provided.

The visiting member may have use of the Host Club's facilities for a cumulative period of not more than thirty (30) days in any single calendar year. There shall be no subscription charge for such period of usage. Specific approval by the Host Club Executive Committee is required for use for longer than thirty days in one calendar year; such approval may depend on the visiting member taking out Temporary Membership of the Host Club.

- 3) Visiting Members may not attend or vote at any Annual or Extraordinary Meeting of the Reciprocal Club and may not participate in the election of Members of the Reciprocal Club.

- 4) Visiting Members granted the use of facilities in the Reciprocal Club shall be required to settle ALL outstanding charges and accounts before leaving the Host Club. The Host Club will ensure that all bills are properly prepared and submitted for this to be effected.
- 5) If the account is not settled by the Visiting Member before leaving the Host Club, the Reciprocal Club shall be responsible for settling the account of its Member to a maximum liability equivalent to Euros 1,000.00.
- 6) *Visiting Members may entertain guests within the Host Club, but the guest is not permitted to remain at the Host Club or use any of the Host Club's facilities unless the Visiting Member is present. If the Visiting Member wishes additional accommodation for non-reciprocal club guests, pre-approval must be obtained from either the Club Manager or the Honorary Secretary.*
- 7) Visiting Members will be responsible for the settlement of any accounts not cleared by their guests.
- 8) Visiting Members are required to comply with all Statutes, Rules and Bye-Laws of the Host Club. The Reciprocal Club will each retain a copy of the Statutes, Rules and Bye-Laws on their premises.
- 9) This Agreement does not provide for a Visiting Member the use of any other Reciprocal Club with which the Host Club has an agreement.
- 10) This Agreement may be terminated by the Committee of either Club upon giving thirty (30) days notice in writing.


